Failure to file it as part of your articles will result in a "request" by the service for you to amend your articles. Just imagine that

Remember that in Pennsylvania we utilize "Registered Offices" rather than "Registered Agents."

The sections that deal with Registered Offices and Registered Office providers are Secitons 1103, 1507, 108, 109. Failure to maintain a registered office puts a company in violation of section 1507 which requires a company to "continuously maintain" a registered office.

"The Bald Eagle was chosen as the United States' national symbol in 1782."

"In 1999, forty-one active nests produced more than forty eaglets. Nearly half of the nests were in northwestern Pennsylvania, on Pymatuning Reservoir and Geneva marsh. Eagles also nested in Pine Creek Gorge in Tioga County; along the Susquehanna River in Dauphin, Lancaster, and York counties; in the Pocono region; on Raystown Lake in Huntingdon County; and along the Allegheny River from the New York Border south to Venango County.

What to do (in PA) when a DE Corporation Qualified in PA converts in DE to an LLC?

Delaware permits a Corporation to convert to an LLC. PA does not permit such a conversion. So what do you do if your DE corporation is qualified in PA and it converts to an LLC back in it's home state? The process is not easy in PA. Simply put you must first register the newly converted LLC in PA as a new entity. You then must withdraw the old DE Corporation or at the very least file an Out of Existence Affidavit.

Fictitious Names come in three flavors...

Individual Fictitious Name, Corporate Fictitious Name and some hybrid created by the form, an individual/corporate Fictitious Name.

Background: Back in the old days there was a form for Individuals to register a fictitious names and one for a corporation to register a fictitious name. Then the Bureau combined the two forms into one.

Now you can (and probably in most cases SHOULD NOT file a fictitious name form with both the individual and a corporation on it as registrants. The big question, if you do that, is do you expose the individual (if that individual is a principal of the company also registering on that form) to individual liability? Word-Lore: Pennsylvania

From "The Facts on File Encyclopedia of Word and Phrase Origins" by Robert hendrickson (Checkmark Books -2000)

Sylvania is the Latin for woodland, and Pennsylvania, formed on the analogy of Transylvania (that home of monsters and werewolves in fiction), means "Penn's woodland." The name does not honor the Quaker William Penn, as is generally believed, but his father, Admiral Sir William Penn (1621-70). Admiral Penn, a naval hero who helped frame the first code of tactics for the British navy, had been imprisoned in the Tower in 1655 for political reasons still unknown, and the author Samuel Pepys speaks bitingly of him in his diary. The crown, however, had become indebted to the admiral, Penn having loaned Charles II 16,000 pounds. On June 24, 1680, the younger Penn petitioned Charles for repayment of this debt, asking for a 300-by-160-mile "tract of land in America..." The tract was to become a colony for Protestant Quakers suffering religious persecution, and Charles repaid his debt with a charter. Penn's account tells us that he suggested the names Sylvania and New Wales. When Charles II added "Penn" in honor of his father, he strongly objected since Quakers are opposed to such use of personal names.

"Bank" is a restricted word...

Bank, when used in a company name, must have the prior approval of the Department of Banking. The Banking law seems to restrict any name that is "deceptively similar" to an existing financial institutions that is subject to the Banking law (see Title 7). The term "deceptively similar" is not defined in the statute as far as I could find so the implementation of the standard is based upon interpretation by the Department of Banking. Today's Tip : Documents - Great Seal Certificate v. Good Standing Certificate

Do you know what a Great Seal Certificate is? The old saying that if it looks like a duck and quacks like a duck it must be a duck will mislead you here. A Great Seal looks like a good standing but it can be something totally different. In fact, a Great Seal certificate can be almost anything you want be. If you want it to be a

certified statement about when a merger happened it can be that. If you want it to be a certified statement that a fictitious name has not filed a cancellation it can be that. The big thing that it is called on to do though is to be a good standing certificate with the date the company was incorporated. Why that? Because Ohio demands that good standing certificates which accompany qualifications in that state must have the date of incorporation/organization on the face of the document.
